

## REGULATIONS FOR THE USE OF THE SKATE-PARK

### USER TERMS OF USE

- The SKATE-PARK can only be used at the times set by the facility.
- To enter the SKATE-PARK you must pay the entrance fee (one use or annual subscription).
- The payment of the entrance fee means that you can use the SKATE-PARK in the time slot in which the use is initiated (morning or afternoon), otherwise you will have to buy another ticket for the next time slot.
- Failure to comply with the regulations will result in the loss of user status and the user will have to leave the facility.
- Users must have their own accident insurance, either Social Security, private insurance or federative card with insurance.

### AGE INFORMATION

- Children under 6 years of age may not use the facility.
- Children between 6 and 12 years of age may use the facility during school hours with a monitor. In addition, they must bring a signed authorisation from their parent or guardian and be accompanied by an adult who is responsible for them.
- Minors between 12 and 16 years old must be accompanied by an adult who is responsible for them and must bring a signed authorisation from the parent or guardian.
- Minors between the ages of 16 and 18 must bring a signed authorisation from a parent or guardian.

### SCHEDULES

- Monday to Friday:
  - From 8:30h until 23:30h.
- Saturday:
  - From 8:30h until 21:30h.
- Sunday:
  - Mornings from 9:30h to 13:30h.
  - Afternoons from 16:00 to 19:30h.

## TERMS OF USE

- The use of helmets is compulsory throughout the Skate-Park.
- The use of knee, elbow and wrist protection is recommended.
- The use of wax or any other slippery element directly on the metal tube (coping) is strictly forbidden.
- The use of metal footrests and pedals or any other material that could damage the installation on bicycles used to use the track is strictly forbidden. The elements of the bicycles that may damage the park must be adequately protected, and the sports centre will be responsible for assessing the value of these protections.
- It is not permitted to practice without a T-shirt. Suitable sports clothing must be worn.
- People who are not skating must remain outside the area delimited by the perimeter fence.
- The facility may be shared by more than one group and mode, therefore, all users of the facility must be respected.
- In case of adverse weather conditions, the user is solely responsible for assessing the condition and difficulty of the Skate-Park.
- In case of rain, the facility may not be used in order to avoid risks and falls. Even if it is not raining, if the track is wet it cannot be used either.
- The capacity of the track is 30 users.

## GENERAL REGULATIONS

- No glass container or food may be brought into the Skate Park.
- Smoking is not permitted on the entire premises.
- Animals are not allowed.
- The general rules of access to Municipal Sports Facilities published by the Municipal Sports Foundation and posted on the notice board of the facility must be complied with.

THE UNDERSIGNED ACCEPTS THE ESTABLISHED RULES OF USE AND IS RESPONSIBLE FOR RESPECTING THEM AFTER HAVING READ THEM.

- I am responsible for the proper use of the facility in compliance with the general regulations.
- Failure to do so will result in the withdrawal of my user status.
- All the information provided is true and I am aware of the rules of use and therefore exempt the centre from any responsibility.
